#### 2012 HAMMAN REUNION

The site of the Hamman Family reunion for 2012 will be Lewisburg, West Virginia, county seat of Greenbrier County. Visiting this area will give us the opportunity to see first hand the sites we have been hearing about: the homestead area of Phillip and Christina Hamman near Greenville, WV; the homestead area of Valentine Cook and historic Cook's Mill near Greenville; the site of Ft. Donnelly near Lewisburg. The exact dates of the 2012 reunion have not yet been decided. However, it will likely be the end of July or first part of August 2012. It's sstill 2 years away, but this is a reunion not to be missed!

#### **DNA CONNECTIONS**

Brian Hamman attended our reunion in Springfield. Although Brian is not likely a direct descendant of Phillip Hamman, he is certainly a direct "cousin" and descendant of Phillip's grandfather. His yDNA is almost identical to our male Hamman descendants, indicating a close genetic tie-in. Brian has been responsible for an extensive survey of yDNA connections with the Hammans. It was Brian's DNA evidence that showed that the Phillip Hamman who arrived on the ship Crawford was not "our Phillip Hamman". DNA evidence shows that Brian's direct ancestor, Henry Hamman (b. 1771 Frederick County, VA, d. 1841 Wayne Co., IN) was a very close relative to our Phillip Hamman. Brian has found a Hamman line going back to Abraham Hamman (b. 17154, New Jersey) that to this point has not been connected to our line. However, the yDNA is such a close match, it is almost certain that Abraham and Phillip Hamman were close relatives too. It is Brian's feeling that Abraham and Phillip were likely brothers, and that Brian's Henry Hamman is a first cousin. It is likely that the father of Phillip Hamman and Abraham is Johannes Haman, first mentioned in 1749 in Oldwick, NJ. Brian followed the likely moves of this Johannes. He feels that there is evidence he's the same Johannes Hamman of Woodsboro, MD 1760-1770. Also, it is likely the same individual as "John" Hamman in 1778 Augusta Co, VA, and Rockingham, VA 1780-1785. This John, and his wife Eve, end up in Wilkes Co., GA, where John dies in 1793. Brian has collected guite a bit of evidence and documentation to back up this theory. So it appears we are connected through the common parents of Johannes Haman and Jacob Hamman (Henry's father). Brian posted the slides he used in his presentation on the Hamman website. We appreciate this significant contribution to finding the parents of our Phillip Hamman. We look forward to more information regarding this new direction of research.

## PHILLIP HAMMAN FAMILY ASSOCIATION REUNION IN SPRINGFIELD, MO

The reunion in Springfield was a tremendous success. On Thursday, July 22, 2010, a large group took a "Safari" day trip to Hickory and Benton County sites. We visited the site of the homestead of Phillip Lacy in Quincy, MO. After Phillip Hamman died in Alabama, daughter Elizabeth (Betsy) Hamman Lacy continued to care for her mother, Christina. After Christina died in 1842, Betsy moved with her son Phillip to Quincy, MO. This area on the frontier of the west was the same area where her brother Valentine Hamman had already settled. We visited Quincy, a rural Missouri town that looks like it hasn't changed in the last 75 years. We had a picnic lunch at the town hall. We then visited the site where Phillip and Martha Lacy, along with mother Elizabeth (Betsy) Hamman had their farm. We visited the cemetery where these 3 tombstones are. We also visited the area of Benton County, just over the county line, where Valentine Hamman homesteaded. It was exciting to visit the area where two of Phillip Hamman's children lived. On Friday, July 23<sup>rd</sup>, the group made a trip to Branson, MO for a day of shows and fun. Saturday, July 24<sup>th</sup>, we all met for several presentations about our Hamman history. We had several presentations including, Phillip Hamman history refresher, status of several lines of Hamman descendants, and the location of the Valentine Hamman homestead in Benton County. We also viewed a presentation about the Hamman historical sites in Greenbrier County, WV. We were also fortunate to have Brian Hamman, detailing Brian's findings of yDNA connections to our Hamman. ## Fascinating Information about Phillip Hamman through DNA research

It had been thought for many years that our Phillip arrived from Germany aboard the ship Crawford on October 16, 1772 along with a Peter Hamman that we thought was his brother. However, now with the new information gathered from the wonderful DNA project on the Hamman/Hammond family, we know this is not the case.

Through the DNA research, we have found that our Phillip's DNA matches that of Abraham Hamman, a revolutionary war soldier who was at the Battle of the Cowpens and at the Battle of Guilford Courthouse. Both of these battles were very important battles of the Revolution in the south. Abraham was wounded in the Battle of Guilford Courthouse at the now present Greensboro, North Carolina.

Now we can surmise that Phillip is probably the older brother of Abraham, alongn with the known siblings of Abraham. If this is the case then we now know that his father was Johan Haman, who was living in Hunterdon County, New Jersey as of 1749 via church records recovered by Brian Hamman. Haman being the way that it was spelled on these records. Johan, or John moved from there to Maryland and on to Virginia. Finally, he settled in Wilkes County, Georgia and passed away there in 1793. There are many Hamman/Hammonds cousins in this area to this day!!!

Here is a list of children of Johan Haman that I found on ancestry.com.

Along with these, probably fits our Phillip Hamman and Brian's Henry Hamman lineages. It is very likely that Phillip is the older brother of this group and Henry may be a brother born in 1765. The DNA shows that this Hamman family is connected. I can't wait for more information forth-coming from this fascinating research!! Great work Brian Hamman!!

# The Mysterious Cal Hamman

Cal Hamman, a son of Phillip Hamman Jr., has been a mystery to many for several years. He didn't seem to show up on any of the census records but was known to be a member of the family and was the first to be buried in the Union Cemetery where Phillip Jr. and wife now lay. He was killed as a young man in the early 1860's, is all that we knew,. Now I have newer information.

Through my research I found that Cal was born john Calaway Hamman on May 10, 1842, a son of Phillip Jr. Cal does show up on census records as John in 1850. I have a list of the names from the old family records of the Phillip Hamman Jr. family which lists the children born of Phillip and Mary Ann Hamman. They are as follows:

John Calaway, along with his brother James Henry, joined the Confederate Army in Kossuth, MS in 1861. They both were in the 23<sup>rd</sup> MS Infantry and fought at Fort Donelson, Tennessee in Feb. 1862. This fort was surrendered and all of the soldiers were taken to Camp Douglas, Illinois on Feb. 16, 1862. However, just before the surrender, General Nathan Bedford Forest's calvary was able to open a hole in the Union lines on the east side of the works, along the Dover road. The calvary and many soldiers were able to escape the surrender through this hole before it was closed back up by the Union forces. Apparently, John Calaway was one of these lucky few. According to his military records, he was listed as location unknown and they show that he was not among the prisoners sent to Camp Douglas. Then on one of the papers it lists him as "assassinated in April", Apparently April of 1862. This would explain the family knowledge of his early death. He was killed near his Mississippi home at Chalybeat Springs. According to one family story, he was on his way to his wedding when he was killed. He didn't arrive and when family members went to search, they found his horse standing in the road and his body hidden in a creek, covered with bramble and brush. His poor mother kept his bloody clothes for many, many years after this due to her grief.

So the mysterious Cal does show up on records, both census and Confederate, and did live a short life as a son of Phillip Jr. and a grandson of Phillip Hamman.
